

# BATTERY ONLY SHIPPING INSTRUCTIONS

**INSTRUCTIONS & SHIPPING LABELS INCLUDED HERE ARE FOR GROUND SHIPPING ONLY.**

## SHIPPING

**IMPORTANT:** Shipping from Alaska, Hawaii, and Puerto Rico prohibited.

- **Ground ship only—no exceptions!**
- Air shipping Li-Ion batteries is prohibited without formal DOT training.
- Shipping only from 48 contiguous states.

## PACKAGING

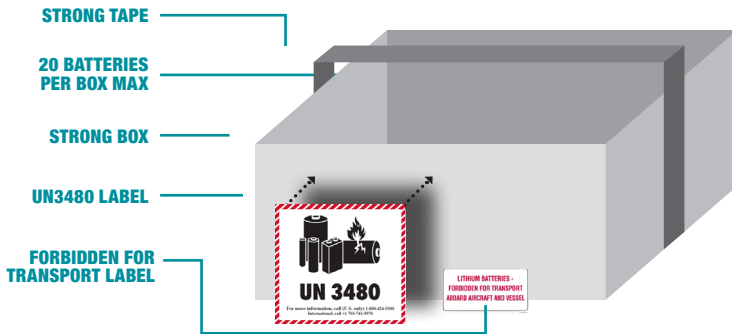
**IMPORTANT:** Package may not exceed a total weight of 66 lbs.

- **Maximum of 20 batteries per box.**
- Each battery must be in a sealed bag or the original sealed clamshell.
- Use a strong box and tape thoroughly.

## LABELS

**IMPORTANT:** Need to obliterate, remove, or cover DG9 (Class 9) label, if on box.

- UN 3480 label must be affixed to box.
- “Forbidden for Transport” label must be affixed to each package with Lithium-Ion batteries inside.



### DOT GENERAL AWARENESS – ENFORCEMENT

- Failure to comply with hazardous materials regulations can result in substantial civil and criminal fines and penalties.
- Each **knowing violation** subject to \$75,000 civil penalty, or a \$175,000 civil penalty for **knowing violation** that results in death, serious illness or severe injury to any person or substantial destruction of property.
- Criminal penalty up to \$500,000 per violation and up to 10 years in prison.

**LABELS MUST BE PRINTED IN COLOR AT 100% SCALE.  
CUT OUT AND APPLY TO THE OUTSIDE OF EACH PACKAGE.**

Labels must be visible and readable and can be placed in clear adhesive document pouch or taped with clear packaging tape.

## SHIPPING

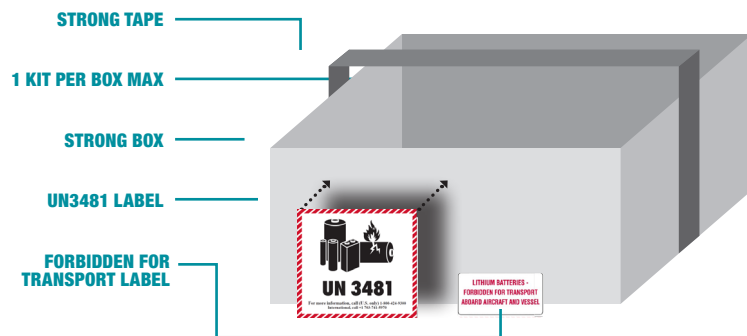
**IMPORTANT:** Do not include more than one (1) tool kit per box.

- **Maximum of 1 kit per box.**
- Batteries must be in a sealed bag, the original sealed clamshell or on tool.
- Use a strong box and tape thoroughly.

## LABELS

**IMPORTANT:** Need to obliterate, remove, or cover DG9 (Class 9) label, if on box.

- UN 3481 label must be affixed to box.
- “Forbidden for Transport” label must be affixed to each package with Lithium-Ion batteries inside.
